## **Disaster Recovery Center Opening in Aurora**

**INDIANAPOLIS, IN** – A Disaster Recovery Center (DRC) will open Tuesday, June 12, in Aurora to help Indiana flood survivors in Dearborn, Ohio and Switzerland counties. The DRC hours are 9 a.m. to 5 p.m. Monday through Friday and 9 a.m. to 2 p.m. Saturday.

Disaster Recovery Centers offer in-person support to individuals and business owners. Recovery specialists from FEMA, the U.S. Small Business Administration (SBA) and the state of Indiana are available to provide assistance to anyone filling out their applications or updating their status. Voluntary organizations are available and offer a variety of services to help survivors recover.

Survivors may visit any open DRC near them. Helpline numbers are open from **7 a.m. to 10 p.m. ET, seven days a week**. DRC information is also available on the [FEMA App](#).

You may have other needs while visiting a DRC:

- If you have a disability and require a reasonable accommodation, please see a DRC manager when you arrive.
- Language translations are offered through Telephonic Interpretation Services in 200 languages.

If you have already registered, it is not necessary to visit a DRC. You may still want to go speak with a Recovery Specialist to update your status, submit documentation, or find help from other organizations.

The SBA offers federal disaster loans for businesses of all sizes, private non-profit organizations, homeowners and renters. The SBA is the federal government's primary source of money for the long-term rebuilding of disaster-damaged property.
