The City of Aurora is accepting applications for a part time or temporary Public Works Laborer. Pay is \$12 per hour, but will depend on qualifications. Temporary and part time employees receive all legally mandated benefits (such as worker's compensation and social security), but are ineligible for the entire City's benefit program (such as health insurance). Hours are generally Monday through Friday, 7:30 AM to 4:00 PM with an unpaid lunch break.
